CIV-101454	Merced	Merced is requesting if the transaction type code for requirement #2 a & b(Revenue & Reimbursement Collection (RP) be changed to state "RevQ Collection" and "RevQ refund" for the transaction types in CIV? This will be consisted with the request to update the recovery account transactions to be accurate to what was receipted in RevQ. 2) Add functionality to verify that the Payment Type in the inbound file matches an existing Transaction Type code (category 412) in C-IV. If the Transaction Type does not exist in C-IV, The transaction will be inserted into the C-IV system using the following existing logic: a) If the transaction amount is positive, set the Transaction Type code as Revenue & Reimbursement Collection (RP). Change to RevQ Collection b) If the Transaction amount is negative, set the Transaction Type code as Revenue & Reimbursement Refund (RR).Change to RevQ refund	Altering the Transaction Types from 'R&R Collection' and 'R&R Refund' to 'RevQ Collection' and 'RevQ Refund' would have impacts across all 40 Counties. This would require a CER requesting an SCR, and voting at the Collections Committee level by all 8 Regions.	Fiscal
CA-206854 CIV-8470	Stanislaus	We asked this question when the SCR was sent to the Usability committee and it was never answered. We are concerned about database integrity and misleading adhoc results if we remove Classification Titles/ Codes that have been used in the C-IV System and replace them with "Temporary Employee." Will C-IV review this during testing for possible data integrity in ad-hoc results?	I would like to provide some clarification on this SCR. Classification Titles are not deleted from the database when a county asks to have a value "removed" from their list. There is an indicator in the database that determines whether or not the value displays on the county-specific dropdown. When a county requests to "remove" a value, this indicator is set to 'No'. Since staff records need to have a classification title, any county staff record associated to a classification that has been "removed" for that county, will be converted to a "Temporary Employee" classification. This population would have to then be re-classified into the appropriate title by the county administrator. Our records indicate that Stanislaus county has not requested any classification title removals. That means Stanislaus titles would not be converted as part of this SCR.	Online
CA-203971 CIV-101764	Region 8	1. Per Recommendation 2a, the following validation will be added to CalACES "A MAGI Determination is not required based on the Requested Medi-Cal Type. Process EDBC without requesting a MAGI Determination". Validation trigger: "Request MAGI" button is clicked. Validation Condition: At least one active or pending individual on the program with "No Potential MAGI" requested Medi-Cal type for the Benefit Month. **Based on this validation message, are we expecting for Mixed Households not to have any individuals with the "No Potential MAGI" requested Medi-Cal type, even if that individual has no potential MAGI eligibility? 2. Per Recommendation 7, Medi-Cal EDBC MAGI budget will be updated to not include individuals with "No Potential MAGI" requested Medi-Cal type. **Does this mean that if a case only has some individuals with the "No Potential MAGI" requested Medi-Cal type, they will not be included in the Medi-Cal EDBC MAGI budget? This should not happen if the expectation is to enforce *No Potential MAGI" requested Medi-Cal type to be used for the entire household. 3. Also, will a design document be created for this SCR? JIRA has no design document uploaded.	1. Renee] Yes. Recommendation 2b requires that "No Potential MAGI" requested Medi-Cal type is used for entire household 2. Renee] In the Medi-Cal EDBC budget rules, a MAGI budget is always created in the rules engine and then if there are no individuals in the budget, the budget will not save into the database. This recommendation ensures that a MAGI Budget is not created in the database, nor displayed when all individuals are "No Potential MAGI" 3. Renee] The design is only in JIRA and no design document will be uploaded. The design started out very small and limited but as we got deeper into the design it grew to be a larger change. Next time a design gets this large, we will transfer it to a design document.	CalHEERS
