CA-204569 CIV-10291	Riverside	The following outstanding issues are noted:  'Variable 27 is still using the open homeless program to determine if homeless assistance was requested but the homeless program is not always opened when a customer merely requests homeless assistance. I still strongly suggest that the Needs page is used to determine if homeless assistance was requested, which should contain a record even if the application as not processed or denied, like after MEDS is reviewed and it is determined the customer has used their once-a-year homeless assistance and they are not eligible to an exception.  'Variable 30's page location was updated as needed, however the field name is still showing as "Need Status" when there is no such field on the page. The field that should be mined is "status"  'Variable 32 was updated to include Employment hours in the criteria and online page location, but did not identify the Employment tables that would be used. I believe that the table that should be used is EMP_MONTH_ACTUAL_EMP_DETL and it should be added to the design document Data Element Specification attachment  'Variable 40 is still not mining for "actual, verified attendance hours" as required by ACL 19-40, attachment 3, page 33. The mapping described on the Data Element Specification document is only verifying the activity status which is not sufficient to determine if a client attended their first activity, with actual verified hours. This mapping needs to be updated to look at the Actual Hours field on the Activity Progress Summary page (CUST_ACTIV_ATTEND)  'Variable 45 is still using the Needs list instead of the Service Arrangement list to identify whether transportation supportive services were issued. Only the Service Arrangement will show whether the transportation supportive service request and actually approved, whereas the Need only indicates it was requested.  'Variable 46 in C-IV the more appropriate field to mine would be Parent's Need Reason, not Special	Variable 27 – LA county does not use the Needs Page to issue HA as Supportive Services. Instead, LA county uses the Needs Page for county funded Homeless Assistance. A worker can always add a HA Perm or Temp from adding a program when a request is indicated.  Variable 30 – Will update and add to Content revision 3  Variable 32 – the CUST_ACTIV_ATTEND table captures attendance related activities including excused hours. In this case, the EMP_MONTH_ACTUAL and EMP_DETL table will not provide accurate activity hours.  Variable 40 – Per discussion with Monica Nguyen and recommendation from CDSS, the criteria to look at the actual hours was removed. Update: awaiting email confirmation from CDSS to confirm criteria and ACL Errata to udpate Variable 40 to Status not Hours. Verbal communication received.  Variable 45 – The Needs list page displays the begin and end date which will help in identifying the measurement period. This information is pulled from the CUST_NEED table.
