Description: (Including any step-by-step instructions)	<p>Purpose The purpose of this CIT is to provide the 40 CalSAWS counties instruction to work a list of Foster Care (FC) programs that have been aided in TANF/Emergency Assistance (EA) aid code 5K for more than 180 days. This list does NOT include FC programs aided in TANF/EA funded due to the emergency caregiver policy.</p> <p>Background ACL 19-24 provided clarification on how long TANF/EA can be claimed. The duration a case can be claimed TANF/EA changed from twelve to six months in Fiscal Year 2019/2020. This does not apply to the emergency caregiver policy, or for cases in Fiscal Year 2018/2019. For more information, refer to ACL 19-24.</p> <p>Additional information SCR CA-214133/CIV-106585 was created to produce a list of cases that may be impacted by the policy change in ACL 19-24.</p>

	<p>The list will have cases with a Date of Risk on or after 03/01/19 that meet one of the following conditions:</p> <ol style="list-style-type: none"> 1. The case was aided with Aid Code 5K-EA beyond the 180th day after the Date of Risk. <ul style="list-style-type: none"> • This can include cases that are already discontinued if they were on 5K for more than 180 days. • This can include cases where the Not to Exceed (NTE) Date was set at 180 days, but EDBC never processed to change the aid code from 5K. 2. The Date of Risk is less than 180 days ago, but the case is receiving 5K funds currently and the NTE is more than 180 days after the Date of Risk so it will be aided with 5K funds for more than 180 days if nothing is changed. <p>The list has the standard columns like other lists, as well as:</p> <ul style="list-style-type: none"> • Date of Risk - the Date of Risk that was used in the calculations • NTE Date - the Not to Exceed date that was used in the calculations • 180 Day Calculation - a calculation of the date 180 days after the Date of Risk <p>County Action</p> <p>If appropriate, based on your county policy, review the cases on the list and make the following updates as needed:</p> <ul style="list-style-type: none"> • If the Not to Exceed (NTE) Date is more than 180 days – Update the NTE text box field on the applicable Placement Authority Detail page to the appropriate date. • If the NTE date was updated, run EDBC for the applicable benefit months to update the program aid code.
