The affected asses were April 2020 renewals discontinued effective May 01, 2020. ackground CR CA-214393 suspended the automated batch process for the Medi-Cal (MC) program in response to MEDIL I 20-07 instructions for public health crisis COVID-19. The suspended discontinuance batches evaluate Medi-Cal programs for Failure to provide or Failure to Complete Redetermination in the LRS System. Although the suspension of the automated batch for the Medi-Cal program is currently in place, in unexpected issue occurred causing some cases to discontinue in the lutomated batch process. The issue is resolved, and no other months will be lifected.

Defect CA-215833 was created to rescind the discontinued cases back to the previous level of eligibility in a one-time batch that occurred on April 29, 2020. A Notice of Action (NOA) will be sent to customers to make them aware their benefits have been rescinded.
