Background

Training Environment

- Counties gave feedback on what was proposed for the CalSAWS Training Environment in the June 2020 Training Committee meeting
 - There is a concern about the lack of resources to maintain training cases and ILTs
 - There is a concern about starting off with a clean/empty slate at refresh, and the resources required to rebuild cases
 - Counties would like a way to copy existing cases into the Training Environment
- Since then, the project has been investigating other options for the training environment that will meet a majority of the counties' needs



Training Environment Solution - Overview

With the new solution, Counties will be able to:

- Access the **Production** environment, and copy cases to the **Training – Staging** environment
- 2. Use the **Training Staging** environment to:
 - Create new Golden Cases
 - Maintain Golden Cases
 - Prepare cases for training scenarios
- 3. Copy cases from the **Training Staging** environment to the **Training Production** environment to conduct training activities
- 4. Specify the number of times a case is replicated. A unique identifier will be appended to cases.



*Golden Cases – A set of fictitious cases that have been created for the purposes of hands-on training and/or training demonstrations. Golden cases can be replicated multiple times to provide the same training scenario during a lesson to multiple end-users. Golden Cases are housed and maintained in the Training Staging Environment as a master copy of cases for training purposes.

Environments & Releases

Case Copy functionality



The releases must be the same for case copy to occur.

There will be other environments that counties can access to preview the upcoming release.

Data Masking

Counties manually mask data

- Data copied from the Production environment into the Training Staging Environment will not be automatically masked
- Counties must manually mask cases in the Training Staging Environment
- The Project will provide guidance on masking





Data Masking - continued

- Why manual masking?
 - Automatic system masking on individual cases does not exist currently
 - The automatic system masking level of effort is high and there are budget constraints
- Individual/personal user accounts will be used in the Training – Staging environment so that data manipulation is tracked



Copying Cases Across the Environments

How it works



Case Copy

The approach

Replicate, Then Individualize Each Case for Training

Cases need to be able to be distinguished from each other; otherwise, people might work on the same case.

Unique Identification of Copied Cases

The need: To be able to distinguish between different copies from the same original case.

When copying from Production and Sally Smith is now masked to John Jones, we need John Jones' case replicated 100 times so that each trainee can add a baby to the case.


It's helpful to have the Case ID unique and perhaps a unique identifier added to a field such as **Last Name**, so that instructors can distinguish between cases (Example: John Jones 1, John Jones 2, John Jones 3)

For example, if Case A is copied to a single schema 100 times, there needs to be some mechanism by which to differentiate the 100 separate cases from each other, so each of 100 students can be assigned to work on a distinct copy of the case.

Solution Summary

- Counties may copy unmasked
 Production cases to the Training Staging environment
- Data copied from the Production environment into the Training - Staging environment will not be automatically masked
- Counties must manually mask cases in the Training - Staging environment
- A Job Aid will detail the procedures on how to manually mask data
- Counties can copy manually masked or golden cases from Training - Staging to Training - Production


User Accounts - A Recap
