CONTRACT NUMBER 07-0001 DATED OCTOBER 29, 2007 (“AGREEMENT”) ENTERED INTO BY AND BETWEEN THE CALSAWS CONSORTIUM (“CONSORTIUM”), A CALIFORNIA JOINT POWERS AUTHORITY, AND FIRST DATA GOVERNMENT SOLUTIONS, LP (“CONTRACTOR”) FOR PROVISION OF THE CALIFORNIA STATEWIDE AUTOMATED WELFARE SYSTEM (“CalSAWS”).

This Amendment Number Seventy is effective as of November 6, 2020 (the “Effective Date”) and amends the Agreement.

RECITALS

WHEREAS, the Consortium requested the Contractor provide Quality Assurance Services and other consulting services (herein referred to as “Professional Services”) that are in addition to the scope of the Agreement as documented in Change Order CO-59 Professional Services (Attachment 67) and reflected in the Attachments to this Amendment No. Seventy. As a result, there is an increase in costs associated with Professional Services to be performed by Contractor.

WHEREAS, Change Order CO-59 is incorporated in the Attachment to this Amendment No. Seventy.

WHEREAS, the Consortium and Contractor desire to enter into this Amendment No. Seventy.

WHEREAS, NOW, THEREFORE, in consideration of the foregoing premises and the mutual covenants and promises described herein, the parties agree as follows:

1. Attached to this Amendment No. Seventy, is Exhibit A, Amendment No. Seventy, which replaces Exhibit A, Amendment No. Sixty-nine, in its entirety.
2. Attached to this Amendment No. Seventy is Attachment 67, which is hereby attached to and incorporated into the Agreement.
3. Capitalized terms used but not otherwise defined in this Amendment will have the meanings in the Agreement. Except as specifically provided in this Amendment No. Seventy, all other terms and conditions of the Agreement are unchanged and remain in full force and effect.
