1 OVERVIEW

The AMP (Application for Measuring Performance) application records the online transaction performance for the CalSAWS application. As part of 39 county migration online transactions are migrated into CalSAWS application. This SCR will review these commands and recategorize them to match the CalSAWS SLA categories.

1.1 Current Design

CalSAWS South categorizes online commands as Screen to Screen, EDBC, Search, Reports/Forms/NOA, and Exception. If an SLA category is not explicitly assigned, new commands default to Screen to Screen.

- 1. Commands are categorized in the database.
- 2. SLA Reports should need no modifications.

2 RECOMMENDATIONS

2.1 Command Categorization

The following commands will be categorized for the listed reasons:

2.1.1 bsd/LocalWarrantPrint/displayLocalWarrantPrint

- Categorize as Exception category.
- This commandtriggers the print of multiple warrants and waits for all the warrants to be printed.

2.1.2 caseregistration/TargetedLowIncome/linkCase

- Categorize as Search transaction.
- This commandperfoms a person search as part of linking a Targeted Low-Income record to a Case.

2.1.3 edbc/FoodStampsEdbc/viewTransitionalFoodStamps

- Categorize as EDBC transaction.
- This commandresults in viewing EDBC calculation results.

2.1.4 planning/certificate/generateCD7617

- Categorize as Reports/Forms/NOA transaction.
- This commandgenerates a Form CD7617.

2.1.5 utilities/processDocument/generateCatlNoa

- Categorize as Reports/Forms/NOA transaction.
- This commandgenerates a Cash Aid Time Limit NOA.

2.2 AMP Application Changes

Transaction categorization will be set in the COMMAND_SLA_DEFN table in AMP schema.

Search transaction type	 Pages with criteria provided to perform search functions, which commonly bring results from various functional areas/cases Pages that act as a building block for a Search page (for example, selecting criteria to be used in a search) Pages with criteria that further refine search results Pages that fetch and display additional details for the user's selected entry from the search results 	
EDBC	LRS online transactions that are related to the Eligibility multi-month calculation business function, and those functions at a broader category include:

Reports	 Online functions that generate or retrieve a standard, ad-hoc or a correspondence report (e.g., Forms or NOAs) are classified as reports 	
Exceptions	 LRS online transactions that interact with external partners/systems (such as EBT, SCI etc.) Online transactions that require re-design or data profile adjustments to address the performance issues and are pending approval. Processes may be marked under the "exception" category until the approval and implementation of the performance changes. Transactions identified and proposed in the "exception" category will be approved by the County Project Director 	
Screen to Screen	 Pages that are not categorized under the above categories are classified under the "Screen to Screen" category, which constitutes a larger portion of the LRS application screen and functions.
