Alameda County asked about the MC RRR for ARs process for CalSAWS.
Currently in Calwin, Alameda county has the MC RRR for ARs being generated in online mode. Specific staff are then printing these MC RRRs and

sending them to the ARs, which is a manual process. Alameda County was asking if CalSAWS would continue this process, or if there is an option to have these MC RRRs for ARs be generated in batch so the print vendor may print and mail the MC RRRs to ARs. Also, Alameda County is curious if other counties are interested in having the MC RRRs generated batch instead of online mode since this procedure was apparently voted on years ago.

It was decided that a request to make enhancements to the Additional Correspondent would be submitted. The enhancement would generate a Renewal packet to an AR when one is designated.
