The Targeted program mode will process EDBCs for CW, RCA, CF, NB, IN, and DV programs from the identified cases which includes all the CW/CF(including NB) combo cases. Note: Because EDBC applies the lower of the standard amount and the Amount Provided, both populations are included. Exclude the following cases: i) The benefit month is past the latest RE due date for the program.

ii) The program has a SAR7 Due Month of 06/2021 and the report status is Sent, Received, or Incomplete
