Several counties asked for the reporting periods to be extended to allow for processing time Claim schedule number are off by at least a month several inquired if it possible for WIS cysle numbers to be amended to correct this issue

Several counties are also missing treasury checks and remittances advices

- Modifying CalWORKs Tax Intercepts: (Pending documentation from State)
  - o To not Delete (Record Type 3) if customer comes back on CalWORKs instead send Decrease (Record Type 2), then if customer goes back off aid send Increase (Record Type 7).
  - Los Angeles is asking for the State policy for Suspsending CalFresh TOP debts if the customer comes back on CalFresh assistance (to not delete the TOP debt). Still waiting on confirmation from the state
- Record Type 4s: (Pending ACL from State)
  - CalSAWS needs to stop sending Record Type 4 for Tax Intercept Reversals. System needs to send a new Record Type V for WIS to know to not forward that information to TOP. ACL still pending with the state
  - CalSAWS needs to send Record Type 4 for the following transaction types (even if the WIS Account is in 'Suspended' Status – send Reactivate (9), Increase (7) and then a week later send Suspend (8) Records):
    - TI Process Refund
    - R & R Refund when the original Transaction was a Tax Intercept payment transaction.
    - Refund when the original Transaction was a Tax Intercept payment transaction.
    - External Refund when the original Transaction was a Tax Intercept payment transaction.

#### **New Business**

- o Since TI is resuming soon and offset letters are being mailed out, here is the possible scenario:

  DPSS receives a returned pre offset letter for the customer. Upon review of the case, we see that tax intercept has already occurred and the amount has been posted. Do we still need to re-mail the notice to the customer? Notifications will still need to be sent out and if they are returned and we take their tax return those will have to be refunded. \*\* pre-offset warning notice shall be sent to delinquent CalWORKs/FS recipients by CDSS at least 30 days prior to intercept for FTB indicating that their name is being referred to FTB for intercept. CDSS shall mail a pre-offset warning notice at least 60 days prior to intercept for claims referred for collection through the IRS indicating that their name is being referred to IRS for intercept.

  \*\*The CWD shall attempt to identify a more current address for cases in which the pre-offset warning notices are returned as undeliverable by the post office.\*\* The State agency must track undeliverable mail and must not refer debts to TOP if notice is returned.
- Counties are concerned about the missing April 2020 Remittance Advice and Deposit. Claim Schedule # 044543A The State had retained that intercept to have on hand in case any refunds needed made due to COVID back in April 2020. The State will now look into this and see where that intercept is at.
