Phase 1 batch 1 SCR CA-215665 & CA-215666 - Taylor Fitzhugh

-Consolidated the items that we previously had across the three different SCRs and moved items from the other SCR documents into this Admin Page SCR.

-Combined marital status dropdowns are now in Batch 1 (instead of batch 3)

-Citizenship – moved changes to add new document type and the GA/GR segment.

- Question Kristin / Orange County
 - Catastrophically ill/disabled
 - Do they have the same field in CalWIN?
 - Yes

-Case Review – Non-Cooperaton updated to allow users to declare whether good cause was determined.

-Several items from Batch 2 or Batch 3 moved to this Batch 1 SCR.

-Living Arrangement changes were consolidated from the different batches and moved to Batch 1.

EDBC Changes - Petereson Etienme

Fleeing Felons – added additional conditional checks

<u>Leins</u> – added section for Leveraged rule. Changed a couple of the mappings for CalWIN to CalSAWS fields.

Status Reasons – Added some additional conditions.

<u>QC Audit</u> – Changed some Data Collection elements mappings. Changes to status reasons, added some conditions.

Probation – no changes

Drug Felon – Added one condition for status reason

Fraud Prevention – Changed data collection mapping

<u>Striker</u> – Added (brought back a rule) and added functionality. Added section with information as to why a rule won't be migrated over. Couple of changes to data collection mapping. Added condition for striker sanction. One change (name change) for one status reason.

<u>Voluntary Quit</u> – Add a couple of rules back. Added Leverage rule section. Indicated one additional leveraged rule and included section for why additional rule won't be migrated. (EDX118C013). Changes to data element mapping. Additional conditional checks for status reasons.

<u>Drug & Alcohol</u> – Add Leverage Rule section. Couple of changes for data collection elements mapping. Changed a couple of status reasons (name and added conditions).

<u>Employment Status</u> – Change data collection mappings, did give additional condition checks for verification section for appointment status. Added a couple of conditions.

Phase 1 Batch 2 SCR CA-229982 - Petereson Etienme

ORG – question about "Relationship Term Not Met". Looks like physical time term that was not met for the relationship to be considered. Would that apply for Domestic Partners or Common Law? This applies to Domestic Partners.

<u>Citizenship/Non-Citizenship Status</u> – Changed rule name. Added a verification section. Added additional checks for status reason.

<u>Undocumented Non-Citizen</u> – Change for data collection element mapping. Added additional conditions for status reason. UP = Unaided Person; FRE = Financially Responsible Excuded

<u>Adult Child Determination</u> – Added section for Leverage rule. Added additional conditions for status reasons, changed verbiage for a couple of conditions.

<u>Sponsored Non-Citizen Cert Period</u> – Add additional rules. Added Leverage Rule section. Added section for rules not migrating. Change in the Data Collection element mapping. Added Verification section. Added additional check conditions for status reasons.

<u>Amount of GA Support</u> – Add additional conditions for status reasons. Verbiage changed on some of the status reasons.

<u>Identity Check</u> – Changed verbiage in rules and added a couple of rules. Added Leverage Rule section. Added section for rules not migrating. Added verification section. Added a couple of conditions & some name changes for status reasons.

<u>Included Individual</u> – Corrected a couple of admin matrix indicators. Added Leverage Rule section. Added "Please Note" and Verification section. Status Reasons, a couple of conditions were added and some name changes for status reasons were made.

	I think we need to consider adding that the client is also not timed-out of CalWORKs to this rule. A scenario was discussed which consisted pregnant in her 2 nd trimester and was timed out of CalWORKs. This rule will fail her for GR but she will also be denied for CalWORKs since out. This puts a pregnant person who is in need of aid to be ineligible for both cash aid programs.
2.	WIC Section 17021 states a person who is not eligible for CalWORKS due to being timed out is not eligible until all of the children are 18 or children are 18 and older except for the unborn, who is not going to receive CalWORKs, then she should be eligible to GA/GR since she is n CalWORKs due to a sanction or a penalty. There is no policy to state she would be ineligible. The 2 nd trimester pregnancy just gives her lini CalWORKs. It's like an incap person applying for SSI or other disability benefits. It's required, but we would aid them if they applied, comp eligible.

-Need to consider adding that the child is also not timed out for CalWORKs. ---Do counties want to add check to not fail the pregnancy rule if pregnant woman is CW timed out?

-SFC already has this rule, if pregnant woman is CW timed out then she is able to get GA until she has the baby.

-The pregnancy rule is the same for all counties.

-For pregnancy, we are not bringing over the CalWIN pregnancy rules.

-CalWIN has is 3rd trimester rules, but that is not being brought to CalSAWS.

-Do all the counties want all the condition mentioned in the email or just specific counties?

-Since this is moved to 21.11 if we can get an answer soon we can get it coded.

-Right now we don't have that condition in CalSAWS.

-Basically, all the counties would have to agree to check if the individual failed CW for CW Time Limit then do not fail the pregnancy rule.

-At the end of the review, a quick vote will be taken for each reason and we will go by the majority.

PREGNANCY CHECK VOTE:

-Do regions/counties want to add additional check to see if individual failed CW for reason CW Time Limit and then NOT fail for Pregnancy rule:

-If added, can it be disabled for a particular county? If you wanted specific rule on/off, you could update the Admin Page. So it would be a new record that needs to be updated in the pregnancy section an entirely separate rule if counties want flexibility to turn on/off.

-Voting by REGIONS not by COUNTIES.

-How many days do counties need for a response? Monday? Caroline will send out email and request Regional response with due date of Monday 6/7/2021.
