Terms

OCR	Optical Character Recognition
Brainware	Hyland's proprietary OCR software
Confidence level	Also referenced as Confidence Threshold
Exception rate	How often a document is sent to the Exception Queue
Splitting	The automatic separation done by OCR to a set of documents imaged at once
Index	The naming of a document

The What

- We are currently only training Person level documents provided by customers
- The initial training and tuning have been completed
- We are working to improve the current index rates by identifying overlap and gathering more sample training documents

OCR Training Process The How

For each Imaging
Form name that will
be OCR'd, a sample
set of documents
were pulled from
C-IV loosely based
on the C-IV
document types.



Brainware reviews each document. It records words and phrases found on the submitted set of documents along with a location, page number and frequency.



Our Hyland partners review the results to determine which words or phrases should be used in the final configuration.

Things to monitor

Court Records - Divorce Decree - Child Support -Child Custody

- Domestic Violence case that references child custody
- Divorce Decree that determines child and spousal support
- Protective order that temporarily assign child custody

Laboratory Work – Hospital Reports – Immunization Records – Pregnancy Verification – Medical Expense

- Statement with labs
- Doctor bill with immunization charges
- Lab test for pregnancy

Shelter – Utility

 Rental receipt that includes sewer, water, gas and electric

Overlapping Forms

Informational

Receipts – Medical Expense – Educational Expense

- Walmart receipts can be either "Receipt" or "Medical Expense"
- Amazon purchases can be either "Receipt" or "Educational Expense" for a textbook
- Home Depot receipt can be either "Receipt" or something else

Miscellaneous pages that are related but have little information related to the document type

- Fax coversheets
- Pages advertising other products and services (e.g., Bank, Utility, etc.)
- Envelopes
- Receipt stamps and notes on the back of a page

Workers Comp – Third Party Liability

• A large number of Third Party Liability documents are centered around a Workers Comp claim

OCR Index Rates

OCR Index Rates

Form Name Statistics

- Indexed is the percent of sample training documents were accurately indexed and archived with the correct form name.
- **Exception** is the percent of sample training documents that could not be recognized and were sent to the Exception Queue.
- Misindexed is the percent of sample training documents that were archived with an incorrect form name.
- Monthly Volume is the percent of C-IV documents that were indexed to the C-IV equivalent document type. The percentage only represents person level documents and does not account for barcoded documents.
