Long Term Solution options for the AAP-FC-KG Resource with multiple Direct Deposit Accts

Sheryl Eppler

- Background: The functionality is different than in C-IV because these caregivers are Resources, and the DD is added to the Resource. But the Resource cannot pay simultaneously to more than one DD account. So if a caregiver wants to use different accounts for different children.
- Proposed Solution #1: Update the direct deposit functionality for resources to be tracked at the program level (similar to C-IV)
 - Pros: Workers can set up separate direct deposit accounts by program. It will also be quicker for CalSAWS to develop and
 - Cons: Resources with multiple children on different programs will get multiple pre-notes for the same direct deposit account. Each new case/program will need an additional pre-note for the same account.
- Proposed Solution #2: Enhance the existing direct deposit functionality on the RDB to be able to store multiple direct deposit accounts.
 - Pros: Less resource entries in the RDB and better management of direct deposit accounts.
 - Cons: This will be a fundamental change to how direct deposits are stored and managed in the System, possibly a 500 to 1000 hour enhancement—which means it would likely take significantly longer to deploy than option 1.
