<ul> <li>This SCR will eliminate the manual process of creating a non-compliance record; batch program will create non-compliance instead of an online solution. Sanction and penalty page to store and populate the summary page for both status records. WtW sweep jobs to trigger EDBC when the CWs is impacted to register for Calfresh. A two parent HH batch job will be created.</li> <li>R6 asked about adding an automatic End Date to the non-compliance. Al: R6will send verbiage for the CRPC, and Caroline will forward to the State for assumption #2 - (referencing R4s email)</li> <li>GA/GR will have a separate effort with SCR #232977.</li> <li>2nd and 3rd assumptions do not impact non-compliance, the rest of the listed are going away.</li> <li>System also needs to look at the CFWR exemption to ensure that we do not miss out the individuals that are not in the home.
