Medical verification of the pregnancy is required to determine CW eligibility for Pregnant Person Only

applicant and the pregnancy special needs (SPN)

Request: Effective July 1, 2021, a pregnant person only (PPO) applicant who cannot provide medical

verification of pregnancy shall be allowed to submit a sworn statement, to verify the pregnancy in

order for aid and the pregnancy special needs (PSN) payment to be authorized.

PPO applicants who provide the sworn statement shall be required to provide the medical verification of pregnancy within 30 working days following submittal of the sworn statement for benefits to continue. After 30 working days, if there is no evidence of good faith efforts to comply, and the application was otherwise approved, aid shall discontinue at the end of the month of the 30-day

period with timely and adequate notice.

The benefits continue beyond the end of the month of the 30-day period, an overpayment shall be

established for any subsequent aided months the pregnant person failed to comply.
