Request: Effective around October 1 2017, San Bernardino has changed their Account Software to SAP.

- a) Collapse 'FAS FUND', 'FAS DEPT' and 'FAS ORG' fields into one 10-digit field labelled 'COST CENTER'. This field will be Numeric only. Left Aligned with trailing spaces. This field will be populated with FUND\_CODE\_MAP.APPR field.
- b) Collapse 'FAS OBJ' and 'FAS APPR' fields into one 8-digit field labelled 'GL ACCT'. This field will be Numeric only. Left Aligned with trailing spaces. This field will be populated with FUND\_CODE\_MAP.OBJECT field

Note: Extending the length of this field will push the remaining fields down.

- c) FAS GRC Code: This field is 7-digits and labelled as 'INTERNAL ORDER'. Left Aligned with trailing spaces. This field will be populated with FUND\_CODE\_MAP.GRC field.
- d) Add a new 30-digit field labelled 'INVOICE NUMBER' below 'EBT Control Number' field. This field will be Alpha/Numeric and allow special characters (dashes). This field will have Payment Request Invoice Number information. Only sent for issuances created off of Payment Requests. Left Aligned with trailing spaces.
- (3) Create a DCR to update the Cost Center, General Ledger, Internal Order information in the Fund\_code\_map table as following:
  - a) Store the SAP\_GL information into FUND\_CODE\_MAP.OBJECT field.
  - b) Store SAP\_CC information into FUND\_CODE\_MAP.APPR field.
  - c) Store SAP\_IO information into FUND\_CODE\_MAP.GRC field.
  - d) Delete the information from FUND, DEPT, ORG columns for San Bernardino county.

#### **Current Design:**

The system will aid a CalFresh (CF) student who is currently a 'Member' with age between 18 and 49, attending school full time or half time in College/Higher Education or Vocational-Classroom Only and meets one of the following:

- Is an 'Active' 'Member' in a CalWORKs program case and currently eligible to CW in the budget month.
- Is 'Incapacitated' or is 'Disabled'
- 'Adequate Child Care' is No or 'Employment & Training Program Participation' is Yes with WIOA, EOPS or Title IV Jobs program OR

'Adequate Child Care' is Yes or N/A and 'Employment & Training Program Participation' is Yes with WIOA, EOPS or Title IV Jobs program OR

Person is in 'Vocational-Classroom Only', and 'Adequate Child Care' is Yes or N/A and 'Employment & Training Program Participation' is No - High School Diploma or Equivalent Not Required

Note: In CalACES, not having Adequate Child Care school is only applicable for CalFresh eligibility if you are attending school full time and have parental control over a household member who is age 6 or older, but under the age of 12

- Exerts parental control over a household member under the age of 6
- Is a single parent or NPCR that exerts parental control over a household member younger than 12 years old and the student has an attendance status of 'Attending-Full Time'
- Has Income with type code of 'JTPA/WIA Earned' or 'College Work Study'
- Is self-employed at least 20 hours per week and receives gross weekly earnings at least equal to the 'Federal Minimum Wage' multiplied by 20 hours OR Is employed at least 20 hours per week and be paid for such employment

The system does not track Cal Grants received by students who meet TANF eligibility requirements and has no ability to provide a student eligibility exemption based on the receipt of Cal Grant (TANF funded) if required.

#### Request:

Per ACL 17-05, a student is eligible for an exemption from the CalFresh student eligibility rule when the student is receiving TANF funded Cal Grant. There are additional programs that qualify a student for an exemption from the CF student eligibility rule.

There is no option to select ABLE/California ABLE (CalABLE) accounts as a property type and withdraws from such accounts as an income type. Savings and investments for disability-related expenses are treated as countable property and income for means-tested public benefits programs such as CalWORKs (CW), which may

result in losing program eligibility or lower benefits for the individuals with disabilities.

Request: Per ACL 17-61, ABLE/CalABLE accounts are excluded as property in determining eligibility for CalFresh (CF) and excluded up to \$100,000 as property in determining eligibility for CW. ACL 17-61 also states that withdrawals from

ABLE/CalABLE accounts for qualified expenses are excluded as income for both CF and CW programs.

Per CRPC 2120, a non-qualified withdrawal from an ABLE/CalABLE account would be considered unearned income and would be counted against the individual for determining eligibility for means-tested public benefits

programs.
