

A Byte of Conversion: What to Expect

Conversion is the migration of (C-IV and CalWIN) data from their existing (legacy) systems into the new CalSAWS. Based on the changes that will be made to the LRS (which will become CalSAWS), the Conversion team will work with the CalSAWS Application Development and Technical Operations teams, as well as the respective Consortium Business Analyst team members, to identify all Target Data Elements required by the system to function.

The Conversion team will then engage with C-IV and CalWIN Application Development and Technical teams, and the Business Analyst(s) to find Source Data Elements from each of the legacy system databases. Data mappings linking Source to Target data are designed and developed, resulting in data transformation, which is used to migrate the data into the CalSAWS system.



During Data Migration, counties can expect:

- The Conversion team to communicate and collaborate with the Counties during the Conversion development lifecycle
- The Conversion team to handle the counties' data with the utmost respect, ensuring that all Personally Identifiable Information (PII) is secure and only teams with a business need have access
- The Conversion team to identify Data Cleansing opportunities for the Counties wherever possible

To prepare for the conversion, counties may want to:

- Take advantage of Data Cleansing opportunities identified and provided by the Conversion team to the Counties
- Participate in Strategic Mapping Work Groups, identified and facilitated by the Conversion team (CRFIs will be sent requesting participation)
- Participate in Data Validation activities during the Mock Conversion
- Work with your Implementation Readiness teams with respect to completing Cutover and Go-Live checklist action items
