 	The Welfare Intercept System (WIS) is used to intercept a person's income tax return, Social Security income, etc. to repay a recovery account. The system will send information weekly to WIS. Then, WIS will share that information with the Franchise Tax Board (State taxes) and the Treasury Offset Program (Federal Taxes). When Tax Intercept transactions come back from TOP, these transactions are automatically posted to the recovery account. The user can view the specifics of the transaction by navigating to the Transaction Detail page. Also, in the system on Transaction Detail page the Edit button is currently displayed for same day created transactions				
Request:	The request is to provide an Edit button which will allow the user to edit comments field when needed. Also, to automatically record the claim schedule number received from TOP interface in the Comments field on Transaction Detail page				
Recommendation:	The Transaction Detail page will be updated to always show the Edit button irrespective of when the transaction is created. For C-IV system, the claim schedule number received from TOP interface will be automatically recorded in the Comments field on Transaction Detail page.
