- 2.1.3 – 1. A. i. – discussion around should this be mandatory prior to the 180 days?
 - Referred us to 2.2.2 – 1.a.
 - Should these cases automatically discontinue if 180 days passes and there is no date added.
 - Request these cases to give the option to go to AC 45.
 - No automated EDBC batch run for this process
 - *During conversion*, if the 180 days is not entered in previous SAW the case will not be discontinued.
 - Currently written to fail the case.
 - Discussion around - if over 180 days can the case go to AC 45. If over 180 days and then the dates were entered worker would need to run EDBC to process the correct state aid code.

- Counties brought up auto-generating a Task to remind staff of upcoming 180 days prior to case terminating.
 - Stated that this was not part of the scope for this DDID but there is another SCR already logged for a similar request that could possibly include this requirement (SCR _____)

- What is the discontinuance reason?
 - Does not meet program requirements is the discontinuance reason. – she will follow up what the proper NOA language will be.
 - Do counties have a current NOA?
 - Suggest looking at CalWIN NOA's as there may be voluntary placement NOA that may fit this scenario. (This has now been Provided by Cathleen Orr from Region 5.)
