•	CER 212188 - WTW Employment Hours- Employment Detail page view	 All regions voted to move forward with CER 21288 with the added required need, of having functionality to distinguish between actual hours versus projected hours when displaying what hours are currently in the system.
		Stanislaus submitted the CER 21288 to request the WTW Employment Hours Detail page allow employment hours to be added for current and future months. Under current design the page is updated after the month has ended and requires monthly update. Under the CER 21288 it is expected to be a time saver by allowing staff to enter in future anticipated hours up 6 months in the future. The discussion included that there is a concern Cal-OAR will only pick up from the area where actual hours are recorded and not where scheduled hours are entered. This CER intent is to enter in future anticipated actual hours to reflect on reports until reconciled actual hours are entered. A request was made to include in this CER for all activities. Clarification provided that WPR instructions only allow projected hours for employment or paid activities.

		 CA208523- Moved to number 11on list. Request is to expand the current Text Message functionality to include WTW. Pushed to priority #11 depending on outcome of the CalSAWS migration.
		 SCR reviewed during January meeting to finish selection of the top 10.
		• Voted #5- CA-208267 Employment Services Goal List to capture the goal status and completion. Currently no functionality to show goals status are completed. The request is for a status for Goals such as, goal completed, actions steps, goal status.

- Voted #6- CA54730 Remove system trigger which updates the Sanction status to Active for a person when the WTW29 signature date has been add but client hasn't completed the activity yet.
- Voted #7- CIV-227 Updated DV activity and Time Limits functionality. Current functionality requires a manual process to change the WTW status from DV good cause to Active. This is needed because the WTW status needs to be in an active status to be able to add a WTW activity. Once entered the WTW status is changed back to DV good cause. This also impacts the Time Limits clocks, WDTIP and WTW25 reports. Labor intensive as it requires several manual updates per month (Time Limits committee has SCR for updating with cases of good cause). The request is to have a WTW Active Status Reason for DV good cause that will allow an activity to be assigned, update Time Limits correctly and trigger the correct information on WTW25. Pending a joint SCR for LRS too.
- Decision to stop at number 7 for now
- SCRS slated to be in the top10 WTW prioritization that were moved to a much larger number on the SCR priority list pending CIV/LRS migration:
 - CIV-9091-Job Readiness Time Tracks are including other Hours when determine the hours counted towards the Job Readiness. LRS does this correctly for the job readiness. Implementing this in C-IV will not be able to occur before the merger. Moved to rereview after migration to CalSAWS. This has been moved to Committee priority 45 or so.
 - CIV-3878-ACL 16-21 CW&WTW participation requirement for pregnant only AU-. The 24 Month Time Limits has not been fully automated in the system and 30 hours federal regulation and 20. State regulation needs to be captured. WTW AU summary. Believe that LRS/CalSAWS may have the functionality in AU summary page. Implementing this in C-IV will not be able to occur before the merger. Moved to rereview after migration to CalSAWS.
 - CIV-542 Require a User to be assigned to WTW program prior to assigning an activity. LRS appears to have this functionality.
