EXECUTIVE SUMMARY

COUNTY FISCAL LETTER NO. 19/20-20

The purpose of this letter is to inform County Welfare Departments of new Program Codes to capture Electronic Data Processing (EDP) Maintenance and Operation (M&O) activities and expenditures for the Child Welfare Services/Case Management System (CWS/CMS) Comprehensive Child Welfare Information System (CCWIS) in accordance with federal policy and guidelines. The percentage share of EDP M&O activities and expenditures for CWS/CMS CCWIS allocation and claiming are released annually in a County Fiscal Letter (CFL) and were most recently provided in <u>CFL No. 18/19-84</u>, dated July 1, 2019.

The purpose of this letter is to inform County Welfare Departments (CWDs) of new Program Codes (PCs) to capture Electronic Data Processing (EDP) Maintenance and Operations (M&O) activities and expenditures for CWS/CMS CCWIS (formerly SACWIS). These instructions identify CCWIS and non-CCWIS categories in accordance with federal policy (45 Code of Federal Regulations § 1355.52 and § 1355.57) and guidelines that were originally communicated in CFL No. 03/04-27, dated October 17, 2003, and most recently updated in CFL No. 17/18-79E, dated September 4, 2018.

Because EDP M&O costs currently cannot be isolated, the CCWIS methodology has been updated so counties will claim CCWIS EDP M&O costs to the County Expense Claim by funding source rather than within existing PCs, with the exception of PC 536 (CCWIS-EDP M&O-IV-E). The new codes include funding from Title IV-E, Temporary CFL No. 19/20-20 Page Two

Assistance for Needy Families (TANF), Title XIX, Chafee, state, and county. The percentage share of EDP M&O activities and expenditures for CWS/CMS CCWIS allocation and claiming are released annually in a Quarterly CFL. The percentages to be used for allocating costs were most recently released in <u>CFL No. 18/19-84</u>, dated July 1, 2019.

Background

California was approved to transition the SACWIS CWS/CMS cost allocation methodology to the CCWIS, as outlined in the FY 2018-19 County Cost Allocation Plan, Chapter X - Statewide Automated Projects. The PCs in the table published in <u>CFL No. 17/18-79</u>, dated June 28, 2018, have been consolidated as subsets of the new PCs reflected in the table below. Effective with the September 2019 quarter, counties must use the PCs in the below table to direct charge CCWIS EDP M&O costs. <u>NOTE:</u> <u>The PCs affiliated with the prior methodology have not been deleted and should</u> <u>still be utilized for all other eligible costs that are not CCWIS EDP M&O</u>.

Claiming Instructions for CCWIS EDP M&O

The following new PCs have been established to capture EDP M&O costs associated with programs utilizing the CCWIS allocation methodology. Beginning with the September 2019 claiming quarter, counties are to direct charge their EDP M&O costs to the PCs below utilizing the corresponding percentage share of costs by fund source. These claiming instructions are for EDP M&O expenditures only; previous claiming instructions related to CWS/CMS activities remain in effect, as stated in CFL No. 03/04-27, dated October 17, 2003. The following PCs are subject to the realignment provisions per CFL No. 11/12-18, dated September 16, 2011.

Captures M&O costs for the Title IV-E Child Welfare Services/Case Management System (CWS/CMS) activities funded at 50/35/00/15 (Fed/State/Health/County). The allocation of costs to all benefitting programs is based on the approved CWS/CMS allocation methodology included in County Cost Allocation Plan (CCAP) Section 3: Intro 1, EDP Costs.

CODE 970 CCWIS-EDP M&O-Temporary Assistance to Needy Families (TANF) 85

Captures M&O costs for TANF CWS/CMS CCWIS activities funded at 85/00/00/15 (Fed/State/Health/County). The allocation of costs to all benefitting programs is based on the approved CWS/CMS allocation methodology included in CCAP Section 3: Intro 1, EDP Costs.

CODE 971 CCWIS-EDP M&O-TANF 50

Captures M&O costs for TANF CWS/CMS CCWIS activities funded at 50/35/00/15 (Fed/State/Health/County). The allocation of costs to all benefitting programs is based on the approved CWS/CMS allocation methodology included in CCAP Section 3: Intro 1, EDP Costs.

CODE 972 CCWIS-EDP M&O-TITLE XIX-Health Related (HR)

Captures M&O costs for Title XIX CWS/CMS CCWIS activities funded at 00/35/50/15 (Fed/State/Health/County). The allocation of costs to all benefitting programs is based on the approved CWS/CMS allocation methodology included in CCAP Section 3: Intro 1, EDP Costs.

CODE 973 CCWIS-EDP M&O-TITLE XIX

Captures M&O costs for Title XIX CWS/CMS CCWIS activities funded at 00/00/100/00 (Fed/State/Health/County). The allocation of costs to all benefitting programs is based on the approved CWS/CMS allocation methodology included in CCAP Section 3: Intro 1, EDP Costs.

CODE 974 CCWIS-EDP M&O-Independent Living Program (ILP)/Chafee

Captures M&O costs for ILP/Chafee CWS/CMS CCWIS activities funded at 100/00/00 (Fed/State/Health/County). The allocation of costs to all benefitting

programs is based on the approved CWS/CMS CCWIS allocation methodology included in CCAP Section 3: Intro 1, EDP Costs.

CODE 975 CCWIS-EDP M&O-STATE ONLY

Captures M&O costs for State CWS/CMS CCWIS activities funded at 00/100/00/00 (Fed/State/Health/County). The allocation of costs to all benefitting programs is based on the approved CWS/CMS allocation methodology included in CCAP Section 3: Intro 1, EDP Costs.

CODE 976 CCWIS-EDP M&O-STATE 70

Captures M&O costs for State CWS/CMS CCWIS activities funded at 00/70/00/30 (Fed/State/Health/County). The allocation of costs to all benefitting programs is based on the approved CWS/CMS allocation methodology included in CCAP Section 3: Intro 1, EDP Costs.

CODE 977 CCWIS-EDP M&O-STATE 50

Captures M&O costs for State CWS/CMS CCWIS activities funded at 00/50/00/50 (Fed/State/Health/County). The allocation of costs to all benefitting programs is based on the approved CWS/CMS allocation methodology included in CCAP Section 3: Intro 1, EDP Costs.
