Yes. The TFS amount would be based on the lastmonth of CalWORKs eligibility and food stamp benefits. (MPP 63-504.131) I was provided with ACIN I-58-08 (pg.19) that has this Q&A to support why the SCR is correct: QUESTION #2: If FR CW cases are not considered to be receiving a cash grant for TFS purposes, how is TFS computed for CW Zero Basic Grant (ZBG) cases? ANSWER: ZBG CalWORKs cases are technically considered to be receiving a CalWORKs cash grant even though benefits have been reduced to "zero," and are not eligible for TFS benefits. Some examples are: 1) If the case is a "zero basic grant" case due to administrative cost, (e.g. no grant is issued due to the payment being below \$10) technically the case is still receiving cash aid, but just not eligible to receive it at present. This case would not be eligible for TFS. 2) If the CW grant is adjusted to zero due to an overpayment adjustment, the household is still considered to be receiving cash aid; therefore, the case is TFS ineligible.	Per this SCR we are not making changes on the TCF logic, it would need to go to a separate effort. The system will function as it currently performs now in regards to TCF. Any CalWORKs/CalFresh combo case where a client requests their CWs program discontinued will not be eligible to TCF. If the CalWORKs ZBG case income eventually goes over the new Tier 2 amount, then the case will fail, and the case will be evaluated for TCF.

The CW 5 is a controlled form in LRS and a state form as well. Therefore, the triggering of the CW 5 will also impact the 57 counties at the time of migration. They will inherit this functionality. Therefore, shouldn't batch job PB19A250, that takes action when the CW 5 form is not returned be updated to not just be LA specific? The other 57 Counties should have an option to opt in or out of the batch job at the time of migration? CA-207407 is updating the Staff Assignment List page, while CA-207206 updated the MAGI Determination List page. Also, why was the content decision made to change the dropdowns to input fields? Seems to be a step backwards in terms of easily selecting those values in a dropdown where now, staff will have to type it in. Where did the content revision request come from? The requirement (DDID 1022) was to just update the Office button to not mandatory. Additionally, LRS today (20.01) does not reflect the updated design of changing the dropdowns to input fields.	I have updated the Jira item for CA-212171 as follows: While PB19A250 is an LA-County Job currently, there is another effort for migration, DDID 1629, to resolve the differences between the systems for automated task creation. The Task generated for this scenario will be reevaluated as part of this effort. At the time the LA Batch job executes, the task is not yet created – the job itself creates the task, not to take any automated negative action. The job looks at the verification due date, and once it has elapsed without the receipt of the form, generates the task.	Batch
