Current Design: The Welfare Intercept System (WIS) is used by the State to utilize Tax Intercept to recover debts for the Counties.

Request: IRS should not be reference with regards to Tax Intercept - the agency should be referred to as 'TOP' (Treasury Offset Program). Five reports in C-IV currently reference IRS.

Request: CalFresh Recovery Accounts are subject to Tax Intercept if they do not have an Active Repayment Term agreement recorded that detail the payment plan for the Responsible Party.

Recommendation: The Collections Committee is asking if we can change out that "EBT Release Form" for CalFresh Recovery Accounts, and instead substitute a "Repayment Agreement" - something similar to the CF 377.7E1, DFA 377.7G or CF 377.7C (it COULD be specific to the Cause of the Recovery Account, but I'm sure everyone would be fine if we made it more generic).

Current Design: When a CalFresh Program is discontinued, any outstanding Recovery Accounts are evaluated for delinquency. If there has been no payment after 30 days, the CalFresh Recovery Account is submitted to the Welfare Intercept System (WIS) to be established at the Treasury Offset Program (TOP).
Request: If an Application (or Reapplication) for the discontinued CalFresh program comes in during the 30 days, the system "resets" the evaluation period for delinquency on the CalFresh Recovery Accounts to 90 days.
Recommendation: The system should not reset the evaluation period when an Application (or Reapplication) for the discontinued CalFresh program is documented. The system should continue counting that same 30 days from the original discontinuance date.

Request: The 2-year Certificate will expire on 08/12/2021, and will need to be renewed before that date

Recommendation: **** No Impact to End User ****

1. Generate a SSL certificate that will be used to authenticate C-IV System's identity when transmitting files to the Tumbleweed server. Register this certificate through Tumbleweed's security administration page.

Note: This certificate will need to be updated every two years in a subsequent SCR.

2. Store the public and private keys associated with the certificate in the existing key ring located on the production batch server. This will allow the batch FTP jobs to securely access the keys during transmission of the files.

The C-IV System and WIS (Welfare Intercept System) both store Tax Intercept Account balance information. Each week, the C-IV System sends Establish, Increase, Decrease, Delete, Suspend and Reactivate transactions to WIS to reflect changes in the C-IV System.

Request:

When transactions error off at WIS, the C-IV System and WIS become out of sync. This causes customers to be notified and intercepted incorrectly.

Recommendation:

1. Create the following change orders:
 - a. Purge the WIS Writer and WIS Outbound FTP Batch Jobs (JOXXF604 and JOXXF644) for 07/xx/2020.
 - b. Purge the WIS Writer and WIS Outbound FTP Batch Jobs (JOXXF604 and JOXXF644) for 07/xx/2020.
 - c. Demand in the WIS Balancer Writer and WIS Balancer Outbound FTP Batch Jobs (JOXXF504 and JOXXF544) for 07/xx/2020.
2. Obtain a test balancer file from WIS prior to 7/xx/2020.
 - a. Analyze the data and verify that the data format is consistent.
 - b. Perform a dry run test of the WIS Balancer Batch Job (JOXXF504) using the balancer file from WIS to test performance.

Note: The dry run test will be performed for Butte, Riverside, Stanislaus and Shasta counties.
3. Obtain a balancer file from WIS before 7/xx/2020 and load the data into the C-IV System.

xx = county number

yy = current year

wk = assigned number for that week (as assigned by TOP)

Request:

Annually, WIS sends an updated 'CDSS Welfare Intercept System Weekly Tumbleweed STS Calendar' to identify the 'wk' as assigned by TOP. This calendar must be loaded into the C-IV System to automatically populate the field in our outbound file.
