Introduction	 Purpose of this meeting is to present the committee with information on the CalSAWS training production environment options for committee decisions. 			
CalSAWS Training Production Environment				
Overview of CalSAWS environments that will be available to the counties	 Overview of the non-production environments that will be available to the counties excluding Training Production and Training Staging (if Golden Case option selected) which are: County Preview, PRT/ Simulation, and Sandbox. 			
Golden case/mock data option	 With the Golden case/mock data option, counties are responsible for creating and maintaining all training data. Cases may be created in the Training Staging environment and copied/replicated to the Training Production environment. Since all Users access these environments as their county, counties cannot update cases in the Training Production environment if they were created by other counties. 			
Masked production data option	 With the Masked production data option, cases from production are copied to the Training Production environment with all personal identifying information (PII) modified. Actual Customer data is NOT imported. Users may create cases in the Training Production environment. Counties may replicate masked production or create cases. 			
 Data refreshes 	 Data refreshes will occur on a frequency/schedule determined by the Training Committee 			
Number of county User accounts needed	 For the number of User accounts to access the Training Production environment, the Project proposes 20% of the county's production Users. These are provided in the slide deck for county decision.
