The GSWs in GROW do not use OCAT.	Our understanding is that the new OCAT link will display in the Task navigation bar under Employment Services (global) > Case Summary (local) and Employment Service (global) > Appraisal (local). Some of the slides in the GROW WBTs show the Employment Services (global) > Case Summary (local) view, so CA-217212 Training: Update Employment Services-GROW WBTs for OCAT Changes was created to update those slides to show the OCAT link. We will not be adding any substantive content about the OCAT appraisal functionality to the GROW WBTs, and updates to the WBTs do not impact functionality within the system itself. I do realize that the ability to see and use the OCAT link is tied to security rights.
