When CalHEERS determines an individual MAGI Ineligible because the individual was enrolled in an APTC/State Subsidy plan and the requested benefit month is prior to the three retro months of transition from Carry Forward, the DER does not provide an Eligibility Evaluation Reason Code (EERC) to explain that for the county worker.

**Request:**

With CalHEERS Change Request 159952, CalHEERS will start sending EERC for 'CFS Ended – Requested benefit month is outside of three Retro Months for MAGI Medi-Cal' in eHIT when the benefit month requested is prior to the three retro months prior to the transition month of Carry Forward.

**Recommendation:**

1. Add the following Eligibility Evaluation Reason Code (CT\_466).

Code: CQ

Short Description: CFS Ended – Requested benefit month is outside of 3 Retro Months for MAGI

Long Description: Carry Forward has completed for this person and the requested benefit month is outside of the three Retro Months period and the person is ineligible to MAGI Medi-Cal due to being eligible for Advanced Premium Tax Credit/California Premium Subsidy in that month.
