Through the review of this report it was discovered that many Recovery Accounts remain open up to the cent level. Request: Modification of the system is necessary to process recoupment accounts that contain cents. 1. Currently the system does not have the functionality to allow the collection of outstanding recovery account balances under a dollar (\$1.00). 2. The system applies the benefit reduction amount greater than the outstanding recovery account balances which in cases with balances that include cents causes excess recoupment in cents. The system does not allow users to refund excess recoupments under a dollar (\$1.00). Recommendation: Enhance the system to fully allow the processing of recovery account collections and refunds of excess recoupment amounts under a dollar (\$1.00) within the Fiscal subsystem. It is recommended that the system be enhanced and allow the processing of these Fiscal Recovery Accounts to the cent level for all programs. Currently only General Relief has the functionality to process recoupment amounts under a dollar. This functionality can be leveraged and possibly be used as a baseline for the other remaining programs.
