Extension of Good Cause Exemption for COVID-19

- Extended to 6/30/2021 or until emergency ends; CIT 0051-20 revised to reflect this and CA-218826 and CIV-107798 automated. ACWDL 8/31/2020 clarifies. CDSS will collaborate with SAWS if state of emergency ends prior to 6/30/2021.

OCAT update

- OCAT UAT started 9/8/2020, scheduled to end 10/12/2020, or 10/9 dependent on holiday on 10/12.
- 9/30/20 and 10/1/20 Champion training sched for (missed dates)
- 11/2/2020 Go-Live
- Old OCAT available for 4 weeks, no set scheduled date.

Cal-OAR update

- ACL 20-95 details one-year pause, Cal-OAR Forum held 9/9/20.
- Cal-OAR to relaunch 6/1/2021, extended to 5-year cycle. Optional for 2020-2021 fiscal.
- LA asked about funding for volunteer counties, answer is yes. County questions need to be referred to CQI specialists.
