

AMENDMENT NO. ONE HUNDRED TWELVE

This Amendment No. One Hundred Twelve (“Amendment”) is entered into as of the 22nd day of January, 2021 (the “Execution Date”), by and between the CalSAWS Consortium (hereinafter referred to as the “Consortium”), and Accenture LLP, an Illinois limited liability partnership (“Contractor”) and Proquire, LLC, an Illinois limited liability company (“Proquire”), and it amends the Amended and Restated Revised System Agreement between the parties, dated as of June 29, 2007 (as amended, the “Agreement”). Unless the context indicates otherwise, capitalized terms that are used but not defined in this Amendment shall have the meaning assigned to such terms in the Agreement. This Amendment amends the Agreement as follows:

RECITALS

The Extension Two Cost Pricing Schedules have been adjusted to reflect Software and Software Support purchases for State Fiscal Years 2020/21 and 2021/22 to support the CalSAWS Customer Service Center Project. The adjustments are implemented and reflected in the Cost Pricing Schedules attachment to this Amendment.

NOW, THEREFORE, in consideration of the foregoing Recitals and the mutual covenants and promises described herein, the parties agree as follows:

1. Attached to this Amendment One Hundred Twelve and incorporated into the Agreement by this reference is Exhibit A, Amendment No. One Hundred Twelve, which replaces Exhibit A, Amendment No. One Hundred Eleven.
2. Attached to this Amendment and incorporated into the Agreement by this reference are Amendment No. One Hundred Twelve Cost Pricing Schedules, which include Extension Two Cost Pricing Schedules which replace Amendment No. One Hundred Eleven Cost Pricing Schedules.

3. Except as specifically provided in this Amendment No. One Hundred Twelve, all other terms and conditions of the Agreement are unchanged and remain in full force and effect.
