### **Returning Business**

- CA-204863 / CIV-102263 ACL 18-99 CF OI Collection Period
  - o Currently in development
    - At last meeting it was left for Counties to consider if they would like any restrictions for this solution – due September 1, 2020.
    - No responses received advocating for any restrictions to be added to the system.
      - Clarification was provided that this ACL speaks to the establishment of Ols.
      - No questions were posed for this SCR.
- ACL 20-24 CALFRESH OVERISSUANCE CLAIMS: COLLECTION TIMEFRAMES, NOTICING REQUIREMENTS, AND THE TREASURY OFFSET PROGRAM
  - Outstanding question: If the CalFresh debt is over 3 years old, and currently in active Intercept status at TOP, then the customer comes back on aid on CalFresh – can we benefit reduce, or should the debt then be terminated for being over 36 months old?
    - Clarification was provided that this ACL speaks to cease sending notifications to former clients.
    - Debts can remain at TOP indefinitely.
    - In this scenario, the collection can be suspended at TOP and benefit recoupment can begin.

# **Topic**

- o SCR's CA-216539 and CIV-107317 Stop sending billing statements after 36 months of customer being off CalFresh aid. (State to consider County concerns, and make the call)
  - Question is still outstanding.
- SCR # CA-218977 Create and send WTW 11 and WTW 12 for WtW/REP/Cal-Learn Recovery Account
  - o Should this be a Top 10?
    - Region 6 is recommending that this SCR be considered as top 10.
- SCR # CA-218978 Create and send WTW 13 for WtW/REP/Cal-Learn Recovery Accounts
  - o Should this be a Top 10?
    - Region 6 is recommending that this SCR be considered as top 10.
- Emergency Allotment CalFresh supplements Should there be an OI
  - o State is working on a Draft ACIN (COVID-19 Overissuances)
    - Clarification still pending whether OIs should be established when EAS benefits have been issued.
    - Can Ols be established if only benefits being received by HH are SMB & TMB benefits?
    - A question arose on whether EAS benefits can be used to pay traditional CF OIs? The short answer is "no", ACIN soon to be issued will provide counties with various scenarios on how to address this and other issues. ACIN is currently in draft form and expected to be released in the next 30 days. CDSS indicated that CF Partners
    - Counties expressed concerns over fiscal ramifications given no guidance has been provided.

#### **New Business**

- CER's to evaluate if an SCR is needed:
  - o CER CA-215248 ACIN I-16-05 Impact on CF Ols
    - SCR will be drafted for the next meeting
- SCR 204762 Do not create Transaction for Overpayment/Overissuance Adjustments
  - Region 6 inquired on when the SCR will be implemented given it currently sits as #2 on top 10 listing. Region 6 expressed a need to have the SCR implemented soon, as the functionally is needed to assist with fine tuning the state reports. Analyst indicated that due to COVID-19 related changes there was no guarantee that any TOP 10 SCRs would be implemented in the next 3 to 6 months, including SCRs that require changes due to state/federal policy.

- Questions / Comments / Ideas
  - Question was posed relating to ACIN I-16-05 how will HH size changes be addressed when calculating
    Ols? CDSS requested for sample scenarios to be sent to be evaluated.
  - Question was posed relating to the 36-month time period, should debts be recalled from TOP?
    Clarification was made that debts can remain at TOP indefinitely. However, you can suspend an account form TOP if there is a current repayment agreement on file. For CW, the debt is deleted on FTB, as there is no functionally to suspend the debt.
  - An inquiry was made as to when the new notices would be available. Analyst would research the SCR and get back to committee.
  - Inquiry was made about stolen benefits. CDSS asked for the questions to be send for a response.
