	Purpose The purpose of this CIT is to notify LRS and C-IV counties that lists for SCRs CA- 224241/CIV-108545 CalFresh Emergency Allotments for February List Posted pertaining to emergency CalFresh (CF) have been posted to the CalSAWS Web Portal. Background To increase food benefits in response to COVID-19 and its effects on the economy, California was approved to provide CF emergency allotments to eligible CF and TCF households. CDSS communicated the approval of CalFresh emergency allotments for the following benefit months: • March and April 2020 CalFresh emergency allotments through ACWDL dated April 2, 2020 (CalFresh Implementation Of The Families First Coronavirus Response Act: CalFresh Emergency Allotments) • May 2020 CalFresh emergency allotments through ACWDL dated 05/21/2020 • June 2020 CalFresh emergency allotments through ACWDL dated 05/21/2020 July 2020 CalFresh emergency allotments through ACWDL dated		

- August 2020 CalFresh emergency allotments through <u>ACWDL dated</u> 08/03/2020
- September 2020 CalFresh emergency allotments through <u>ACWDL dated</u> 08/24/2020
- October 2020 CalFresh emergency allotments through <u>ACWDL dated</u> 9/29/2020
- November 2020 CalFresh emergency allotments through <u>ACWDL dated</u> 10/30/2020
- December 2020 CalFresh emergency allotments through <u>ACWDL dated</u> 11/30/2020
- January 2021 CalFresh emergency allotments through <u>ACWDL dated</u> 01/04/2021
- February 2021 CalFresh emergency allotments through <u>ACWDL dated</u> 01/29/2021

All CF and TCF households not already at the maximum allowable allotment based on household size are eligible to receive a CF emergency allotment. Example: A household of 2 received \$150 in CalFresh in April 2020 received a \$205 CF emergency allotment on May 9th to bring them up to the maximum allotment amount of \$355 for 2 people.

CF households that previously received the maximum allowable allotment based on household size are not eligible to receive CF emergency allotments.

SCRs CA-224241/CIV-108545 CalFresh Emergency Allotments for February List Posted was implemented on 03/06/2021. This SCR issued emergency CalFresh benefits to CalFresh (CF) Households who had not already received the maximum benefit allotment for the **December 2020**, **January 2021**, and **February 2021 benefit months**.

Additional Information

CalSAWS implemented an automated process to issue the CF emergency allotments for eligible CF and TCF households. The automated process raised each household's regular monthly CF allotment to the maximum allowable allotment based on the household size.

Previously, the CF emergency allotments were issued as a 'Supplemental Disaster CalFresh' (Supp DCFP) benefit type on the household's EBT card. However, with SCR CA-218299/CIV-107689 and moving forward, the emergency allotments will be issued as 'Emergency Allotment Food Benefits' (CF03) benefit type.

An automated journal entry was added to all cases receiving a CF emergency allotment.

 December 2020, January 2021, and February 2021 benefit month emergency allotments generated on March 6th are available to the recipient as of March 7th.

Users will be able to view these emergency allotments on the 'Issuance Detail' page as 'Emergency Allotment' in the Subcategory field; they will also be visible on the 'CalFresh EDBC Summary' page. Since the CF emergency allotments are



issued as an Emergency Allotment (CF03) benefit type, County users are not able to issue these emergency allotments through the system manually. Cases that receive a Validation/Submission error can be found on the 'Issuance Exception Report' and will need to have action taken to avoid a duplicate error in the next run. NOTE: The next CF emergency allotment batch issuance will occur of April 17th, 2021. This run will include the first emergency allotment issuance for March 2021, the 2nd issuance for February 2021, and the 3rd and final issuance for January 2021. **County Action** 1.
