Description: (Including any step-by-step instructions)	<p>Purpose The purpose of this CIT is to inform the C-IV and LRS counties of the implementation of SCR CA-225692/CIV-108674 to apply the COVID Good Cause exemption to exclude individuals who have used 61 or more months of TANF and more than 48 months of CalWORKs.</p> <p>Background Executive Order N-75-20 extends the provision for the Lack of Supportive Services- Good Cause exemption applied to the CW 48-Month and WTW 24-Month Time Clock until June 30, 2021, or until the termination of the State of Emergency, whichever is sooner. ACWDL August 31, 2020 details how the exemption should be applied.</p> <p>Additional Information The COVID good cause exemption does not apply to the CalWORKs 48-Month Time Clock for individuals who have received 61 or more TANF months of aid or more than 48 months of CalWORKs. There are individuals who exceed the CalWORKs 48-Month Time Clock limit and may have received the exemption erroneously from November 2020 to March 2021. CA-225692/CIV-108674 will apply the exemption from April 2021 until June 2021.</p> <p>County Action</p>
