Each week, the C-IV System sends Establish, Increase, Decrease, Delete, Suspend and Reactivate transactions to WIS to reflect changes in the C-IV System. Request: When transactions error off at WIS, the C-IV System and WIS become out of sync. This causes customers to be notified and intercepted incorrectly. Recommendation: 1. Create the following change orders:

- a. Purge the WIS Writer and WIS Outbound FTP Batch Jobs (JOXXF604 and JOXXF644) for 07/24/2020.
- b. Purge the WIS Writer and WIS Outbound FTP Batch Jobs (JOXXF604 and JOXXF644) for 07/31/2020.
- c. Demand in the WIS Balancer Writer and WIS Balancer Outbound FTP Batch Jobs (JOXXF504 and JOXXF544) for 07/31/2020.
- 2. Obtain a test balancer file from WIS prior to 7/01/2020.
 - a. Analyze the data and verify that the data format is consistent.
- b. Perform a dry run test of the WIS Balancer Batch Job (JOXXF504) using the balancer file from WIS to test performance.

Note: The dry run test will be performed for Butte, Riverside, Stanislaus and Shasta counties.

3. Obtain a balancer file from WIS before 7/29/2020 and load the data into the C-IV System.

Current Design: CalFresh Recovery Accounts can be established at the Treasury Offset Program (TOP). If a customers' income

tax is intercepted. If TOP reverses the intercept, TOP increases the amount of the TOP account by the amount of

the reversal.

The county is notified of the reversal on the "TOP Weekly Reversal Report" and the county will manually post a reversal transaction on the C-IV Recovery Account which will increase the balance owing on the C-IV Recovery

Account equal to the amount of the reversed intercept.

C-IV will send a Record Type 7 (Increase) to the Welfare Intercept System (WIS) for the amount of the reversed

intercept, which will increase the balance owing at WIS equal to the amount of the reversed intercept.

WIS will send an Increase Record to TOP for the amount of the reversed intercept, which will increase the balance

owing at TOP (doubling the amount owed by the customer by the amount of the reversal).

Request: WIS has implemented a new Record Type V, which will increase the balance of the WIS debt without increasing

the balance of the TOP debt.

Recommendation: Update the Recovery Account Transactions:

Tax Intercept Reversal - change to 'TOP Initiated Reversal' TI - Process Refund - change to 'TI - County Initiated Refund'

When a "TOP Initiated Reversal" is posted, System should send a Record Type V for the amount of the

Transaction to WIS.

When a 'TI - County Initiated Refund' is posted, System should send a Record Type (??4 or 7??) for the amount

of the Transaction to WIS.

NOTE:

Record Type 4: Reported to both WIS and TOP. Informational only, does not affect any balances.

Record Type 7: Reported to both WIS and TOP. Increases balance at both WIS and TOP.

Record Type V: Reported to WIS only. Increases WIS Balance.
