Description: (Including any step-by-step instructions)	<p><b>Purpose</b></p> <p>The purpose of this CIT is to inform counties that the Good Cause Exemption under reason code 407 will be extended starting July 1, 2021 until the implementation of the CalWORKs 60 Month-Time-Clock currently scheduled for May 1, 2022.</p> <p><b>Background</b></p> <p>CalSAWS was informed via Consortium Request for Policy Clarification (CRPC) 2250 that the CalWORKs time limit Good Cause Exemption will be extended starting July 1, 2021 until April 30, 2022. The WTW 24 Month-Time-Clock time limit months will continue to not tick until the repeal of the WTW 24 Month-Time-Clock. This CRPC was shared and discussed at the Time Limits Committee meeting in May 2021 and the CalWORKs/CalFresh Committee meeting in June 2021.</p> <p><b>Additional Information</b></p> <p>SCRs CA-228754/ CIV-10917 will apply the Good Cause time limit exemption to CalWORKs recipients who have time remaining on their CalWORKs 48 Month-Time-Clock who do not have another existing exemption. TANF time on aid will no longer be considered in the exemption eligibility determination. SCR CA-228754/CIV-10917 are scheduled for Release 21.06.30.</p>
