Background CalSAWS member Counties are required to pay a County Share of Costs of the CalACES, CalSAWS, and CalWIN systems. The County Share of Cost is calculated based on Persons Count. It was agreed that the method of payment would be in the form of an adjustment to each County's CalWORKs Administrative Advance. The Third Quarter of SFY 2020/21 will be applied to the July 2020 mid-month advance, reflecting each County's Share of Costs. The adjustment should be noted on each County's AA190.
