

Purpose: There is a nightly Batch EDBC Run for CalWORKs, CAPI, RCA, General Assistance/General Relief, CalFresh and Non-MAGI Medi-Cal, that is triggered when program specific mandatory verifications are in pending status after their due date.

The Batch EDBC applies to mandatory verifications only and will cause a program(s) to discontinue or decrease benefits when the verifications are in an overdue pending status.

The following table provides the CalSAWS Mandatory Verification Types by program.
