Description: (Including any step-by-step instructions)	<p>Purpose (Identify what Counties this CIT affects)</p> <p>The purpose of this CIT is to provide all 58 counties with information on the status of the CalSAWS Analytics Dashboard and Reports Replatform effort. The effort, which will include Dashboards and Reports leveraged from LRS, C-IV, and CalWIN, is currently in progress in a phased Analytics Release deployment schedule, and it is projected to be completed by the Fall of 2022.</p> <p>The CalSAWS Project is scheduled to deploy its fourth Hard Launch Release of replatformed Dashboards and Reports into Production on September 15th, 2021.</p> <p>Upon deployment of this fourth Hard Launch, the Project will have replatformed 28 Dashboards and 277 State & Management Reports currently residing on the LRS and C-IV systems.</p> <p>See attached “Dashboards & Scheduled Reports Replatform Release Summaries” and “On Request Reports Replatform Release Summaries” documents highlighting the visualization variances between the two platforms and what has been replatformed thus far in Releases 1, 2, 3, and 4. This is the first Release in which C-IV-Only Dashboards (Call Log, Semi Annual Reporting, & WPR and Engagement) are being replatformed.</p>

Also included is the CalSAWS Functional Presentation (CFP) video of the CalSAWS Enterprise solution for Reports and Dashboards tool, **Qlik Sense**.

This CFP provides a high-level overview of Qlik Sense functionality and highlights the differences between the current tool for reports and dashboards called Oracle Business Intelligence Publisher (OBIEE) and the new tool Qlik.

Note: This CFP does not address specific dashboards or reports, as it is intended for a global audience, and there is no current plan for future CFPs to address specific dashboards or reports, as these are being discussed in webcasts for respective Releases.

Background

A proof of concept was completed in 2018 to identify the benefits and impacts of CalSAWS in the Cloud. It was found that Dashboards and Reports could not scale with the estimated CalSAWS volume of data for 58 counties. The decision was made to invest in a cloud data architecture that supports the future growth of CalSAWS.

The CalSAWS Analytics solution objective is to replatform the existing Business Intelligence and On Request & Scheduled Reporting solution to the new high-performance cloud-hosted platform **Qlik Sense** to support all SAWS.

Benefits of this new platform include:

- o Enhanced user experience
- o Performance Improvements
- o A single platform allows for enhanced support for the counties

Additional Information

One of the features outlined in the CFP video is Storytelling which is an excellent method in combining reporting, presentation, and exploratory analysis techniques in Qlik to create and share a collaborative experience. As indicated in the CFP video, this feature will be further explained in a future CFP.
