I I	The RCA discontinuance jobs will start to run on 09/17/2021 to discontinue RCA cases effective 10-01-2021 for RCA recipients, who have entered the US for eight (8) or		

more months, are receiving RCA benefits and for cases that **do not** have an EDBC override.

Note: RCA is limited to eight months from the Date of Entry.

Additional Information

The RCA discontinuance jobs will not run active RCA cases with overridden EDBC results due to the implementation of extended eligibility beyond the standard eight-month time limit. For overridden cases, users need to run EDBC online to apply the discontinuance logic for RCA cases with US date of entry 8 months or more.

 - 1. From the Active RCA Case List Filter out the Entry Date from 02/2021 and onward.
 - 2. Run EDBC with Begin Month: 10/2021
 - 3. Review: EDBC results and NOAs.
 - 4. Follow your county process to suppress or manually generate the NOAs.
 - 5. Accept and save the EDBC.
 - 6. Follow your county policy to Journal all actions taken.
- 2) Review the pending RCA case list, follow your county requirement to process those pending RCA cases.
