This CIT contains the URL for the CalSAWS Jira instance.
	Background
	Currently there are two Jira instances leveraged by the CalSAWS Project to maintain and track SCRs and Defects. There is the C-IV instance as well as the CalSAWS instance. With the C-IV County migration to the CalSAWS System, only the CalSAWS Jira instance will be used going forward. This CIT provides the link to that CalSAWS Jira instance for users who may not already have been provided the link.
	If you are a User who has access to the C-IV Jira today, you already have access to the CalSAWS Jira instance, you will just need to access it using the link provided below.

# **Accessing C-IV Jira**

Once C-IV Counties migrate to CalSAWS the C-IV Jira instance will remain available, but all future SCRs and Defects will be managed from the CalSAWS Jira instance. There are future plans to decommission the C-IV Jira instance and archive some of the data, however, those details are still pending. A future CIT will be disseminated once those details are finalized.

## **Data Migration**

None of the data from C-IV Jira will be migrated to the CalSAWS Jira. If there is a specific C-IV SCR in Jira that does not already have an equivalent SCR in CalSAWS Jira, please work with CalSAWS Project Consortium Staff to have that SCR created in the CalSAWS Jira.
