<p>Description:</p>	<p><b>Purpose</b> The purpose of this CIT is to provide counties with the CalSAWS WINS job aid.</p> <p><b>Background</b> WINS is a \$10 per month supplemental food benefit program for working families who are receiving CalFresh benefits but not receiving California Work Opportunity and Responsibility to Kids (CalWORKs) or Tribal Temporary Assistance to Needy Families (TANF) benefits. Eligible CalFresh households are eligible if they meet WINS work requirements and will receive one WINS benefit each month. The WINS benefit is distributed on the household's existing Electronic Benefits Transfer (EBT) card as a food supplement to the family's CalFresh allotment.</p> <p><b>County Action</b> The CalSAWS WINS job aid will be added to Online Help (SCR CA CA-232469) with the 22.01 release which will be available on 1/24/2022.
