Description: (Including any step-by-step instructions)	<p>Purpose</p> <p>The purpose of this CIT is to provide the managed CalSAWS counties the new Domain Controller IP's (from the Equinox Data Center) that will be replacing the DDC and PDC Data Center Domain Controllers. These IP addresses will need to be allowed to communicate with the Domain Controllers at the existing County sites.</p> <p>Background</p> <p>The C-IV Data Centers (DDC and PDC) are going to be decommissioned. The existing Managed County's Domain Controllers at these sites will be moved to the new Equinox Data Center locations. As part of the move the domain controllers at these sites will receive new IP addresses. Managed Counties will need to open communication to the new IP addresses.</p> <p>County Action</p> <p>PPOCs are responsible for sharing this communication with their TPOCs.</p> <p>Counties should complete the below activities by November 19, 2021</p>
