Background Previously CIT 0339-21 CA-235992 – List of Cases with Potential for "Get Duplicate Aid" in Medi-Cal was issued to provide information to Counties on the Duplicate Aid check functionality within the system. CA-235992 included a list of cases with ndividuals that have been discontinued due to reason of "Gets Duplicate Aid" since the migration occurred on 09/27/2021.  SCR CA-232611- Update the duplicate aid check for MC was created to address multiple issues related to the duplicate aid check. This includes updating the 'Gets Duplicate Aid' rule to no longer check for the state and/or county assigned to the MC or cash-based MC Other Program Assistance (OPA) record when determining Gets Duplicate Aid' for the Non-Modified Adjusted Gross Income (Non-MAGI) or Medicare Savings Program (MSP) Medi-Cal budget. The OPA record should be used in the comparison for 'Gets Duplicate Aid' regardless of the county where the duplicate aid is received. CA-232611 was released in a priority release on December 8th, 2021.

#### Additional Information

A list of cases with individuals that have been closed with a failed budget for "Gets Duplicate Aid" from a Medi-Cal program has been re-generated in order to capture any additional individuals that may have been discontinued since the list for CA-235992 was run on November 10, 2021, and the release of CA-232611 on December 8, 2021.
