

- 2) Extend CW48 months and WTW 24 months through 04/30/2022




- ▶ On January 8th, 2022 CalWIN implemented a January Monthly Release

- ➤ On January 15th 16th, 2022 CalWIN performed an extraction for Wave 5 and 6 counties




