



Figure 4.1.5-1 – CalSAWS Analytics – Release J Burndown (State & Management)





Figure 5.1.2-1 – DDID System Test Status








Figure 5.1.4-1 – Task Management Design Difference Identifiers (DDID) Status





Figure 5.1.6-1 – GA/GR DDID Status

Figure 5.1.7-1 – Case Purge Burndown Chart



Figure 6.1.4-1- Ancillary Systems Conversion Gantt Chart


