 - o 'Inter-County Transfer' (85)
 - o 'Gets Tribal TANF' (KD)
 - o 'QC Refused to Cooperate (CW)' (XE)
 - o 'QC Failed to Respond in 30 Days (CW)' (XG)
 - o 'QC Failed to Keep Appointment (CW)' (XI)
 - o 'QC Failed to Keep 2 Appointments (CW)' (XK)
 - o 'QC Failed to Sign Release (CW)' (XM)
 - o 'QC Failed to Return Signed Release (CW)' (XO)
 - o 'SAR 7 Incomplete' (SC)
 - o 'SAR 7 Not Received' (SD)
 - o 'CW RE Incomplete' (YA)
 - o 'CW RE Not Received' (YB)
 - o 'Failed to Complete Determination' (16)

- All the applicants on the 'CalWORKs' program must not have been closed for one of the following reasons:
 - o Deceased (04)
 - o California Residence (05)
 - o CalWORKs IPV (AK, AL, AM)
 - o No Show for QC/QA (A7)
 - o Refused Job (B6, B7, B8)
 - o Quit Job (B9, BA, BB)
 - o CalWORKs Nonparticipation (BC, BD, BE)
 - o Reduced Earnings (BF, BG, BH)
 - o Didn't sign WTW Plan (BI, BJ, BK)
