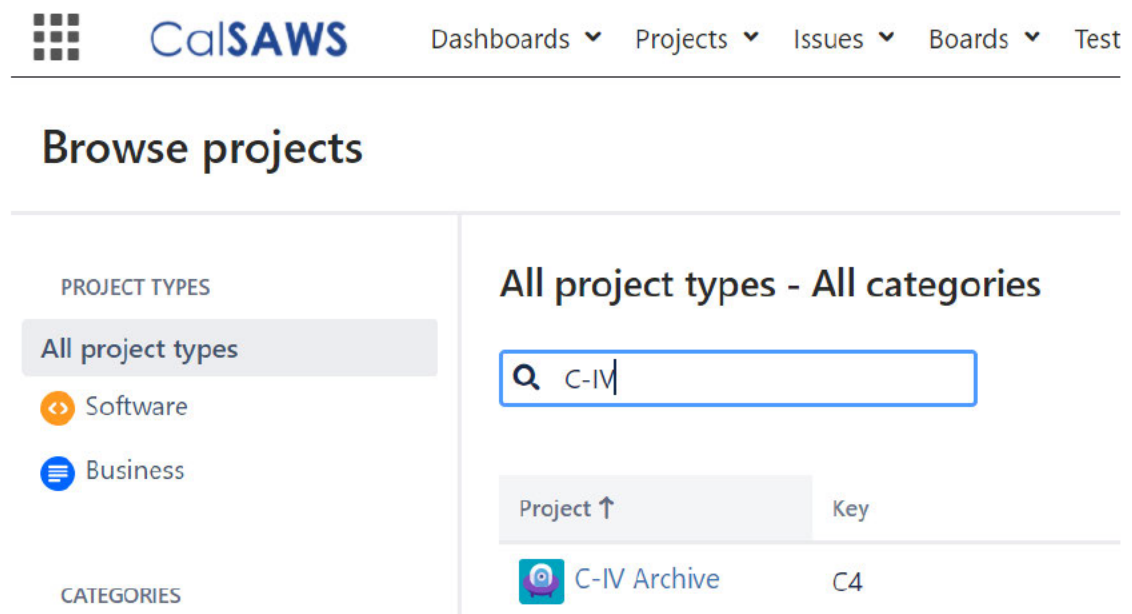
Description: (Including any step-by-step instructions)	<p><b>Purpose (Identify what Counties this CIT affects)</b></p> <p>The purpose of this CIT is to provide an update on the decommissioning of the C-IV Jira instance and the archiving of the SCRs and Defect data within that tool.</p> <p><b>Background</b></p> <p>With the migration of the C-IV Counties into CalSAWS, the CalSAWS Jira instance is the only tool currently being used. Access to the CalSAWS Jira instance was provided in CIT 0271-21. The C-IV Jira instance will be decommissioned on January 21, 2022.</p> <p><b>C-IV Jira data archive</b></p> <p>All C-IV SCRs and Defects will be archived and moved into the CalSAWS Jira instance within a new Jira Project called C-IV Archive. This will allow Users to still access the historical C-IV data, as needed.</p>

When searching for a C-IV Jira item, Users will need to use the following format:  
C4-<Old C-IV Jira item number>.

Example: If you are searching for item CIV-109417, you will need to enter C4-109417 in the CalSAWS Jira search box to pull up that item (see image below for example).
