Description: (Including any step-by-step instructions)	<p><b>Purpose</b></p> <p>The purpose of this CIT is to release the Job Aid titled “Medi-Cal CalHEERS – BREFS Application Life Cycle” prior to being published in CalSAWS Online Help. This job aid is related to SCR CA-221715 BREFS Initiative 10: CalHEERS Application Life Cycle. The functionality will be in CalSAWS on February 21, 2022. The job aid will be published in the CalSAWS 22.03 release (scheduled for March 21, 2022).</p> <p><b>Background</b></p> <p>As one of the Business Rules Exposure for SAWS (BREFS) initiatives, the Application Life Cycle now allows SAWS to display information from the Electronic Health Information Transfer (eHIT) for an individual's Modified Adjusted Gross Income (MAGI) Medi-Cal and Advanced Premium Tax Credits (APTC) Budgets. CalSAWS did not receive or store information about Negative Actions and/or Non-Compliance reasons applied to an individual under the budget sections in the System.</p> <p><b>County Action</b></p> <p>Review the attached Job Aid, which explains how and where to access the Negative Action and/or Non-Compliance actions taken on a case in CalHEERS being displayed in CalSAWS.</p>
