Happy New Year! 2022 continues our transition to CalSAWS. In 2021 we successfully reduced the number of eligibility systems in California from **three** to **two**. This was a historic event which resulted in 40 Counties using CalSAWS, the implementation of BenefitsCal in 39 Counties and the retirement of the C-IV and C4Yourself systems. While we are still supporting the 39 Counties in their transition to CalSAWS, we are looking toward the future and moving to **one** Eligibility System in California.

The various teams are transitioning to fully supporting the migration efforts for the CalWIN Counties and planning for Implementation Support, Change Management and Training for the Wave 1 Counties whose go live is less than 10 months away. The teams are also supporting the implementation of Imaging and BenefitsCal in Los Angeles County in March.

The Power of 58 is more important than ever as the CalSAWS team and the counties work together to get us to **ONE!**

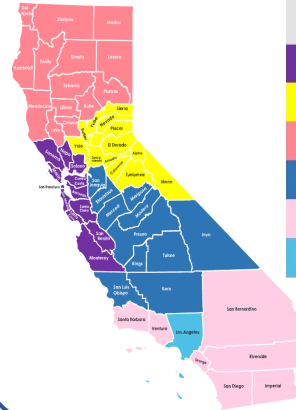
CalSAWS Conversion – CalWIN Wave 1

The last time CalSAWS Conversion was featured in the Buzz, we had just kicked off the CalSAWS Project. Since then, the C-IV Conversion Team mapped and migrated the counties' data into CalSAWS (🍌) and C-IV has been retired (😞).

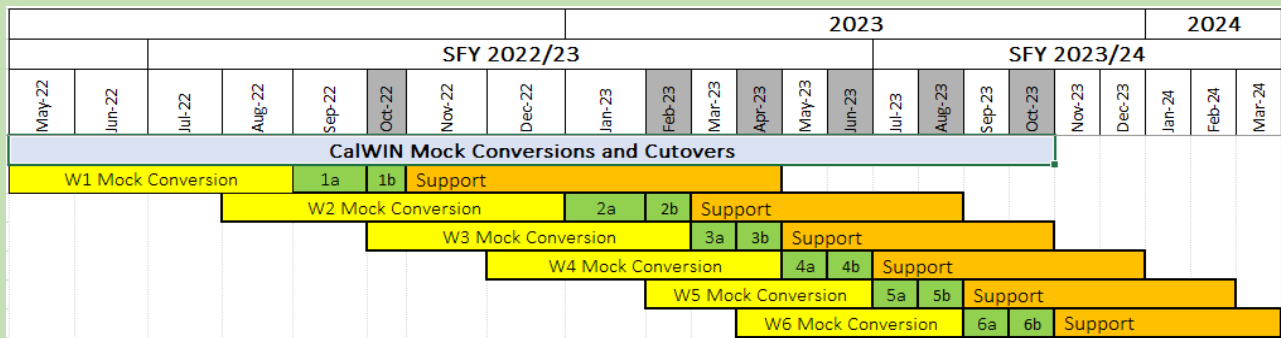
At the same time, in a parallel workstream, the CalWIN Conversion Team has mapped the CalWIN counties' data to CalSAWS. Presently, the CalSAWS Converted Data Test team is testing the CalWIN converted data to ensure the converted data can be used to perform day-to-day county business activities in the CalSAWS application.

Following CDT, CalWIN counties will start UAT...and the CalWIN Conversion Team will start performing Mock Conversion (aka Mock Cutover) in preparation for CalWIN Wave 1 (Contra Costa, Placer, and Yolo Counties) Cutover in October. And then the 5 remaining waves commence in February 2023, a wave every 2 months. See the Gantt chart below.

CalSAWS Central Print Update

The Central Print team had a successful Phase 1 go live and a smooth transition of print and mail services for Los Angeles County. A short month later, Phase 2 go live was also successful, adding 39 counties to Central Print. So far Central Print has printed over 75 million impressions and mailed over 9 million envelopes. The Central Print team is also excited to announce that Contra Costa and Tulare Counties have chosen to join Central Print which will result in **all 58 California Counties on Central Print** at the end of Phase 3.

Center of Excellence

On June 28, 2019, the 58 California Counties came together as one Joint Powers Authority to initiate the CalSAWS Project and Consortium, which will operate under one system by 2023. The Consortium-IV system retired on September 24, 2021, and the 39 Counties migrated to the CalSAWS solution completing a milestone towards the project vision.


Like with any change, adoption can be challenging, and C-IV counties requested dedicated post-implementation support model to enable success after the transition. A Center of Excellence (C.O.E.) comprised of experienced Change Practitioners was created and deployed to engage C-IV counties, understand support needs, and execute interventions tailored by County to address all areas of need. The C.O.E. successfully completed their efforts on December 17, 2021.

C.O.E. Approach

The C.O.E. began its work by implementing a human-centered approach to identify county needs. Working with regional managers, the C.O.E. established a meeting cadence with each C-IV county consisting of 3 meetings:

- 1st to highlight our existing understanding of county needs based on county data (e.g., training completion, # of helpdesk tickets, survey assessments) and iterate following our framework of listening and collaborating to pinpoint hotspot areas
- 2nd to collaborate and agree on a strong plan of action consisting of tailored interventions (e.g., workshops, learning aids, office hours) to address the hotspot areas such as knowledge gaps and frequent 'how to' questions
- 3rd to gather feedback on how effective our interventions were after we had executed the action plan and to address and close out any open items

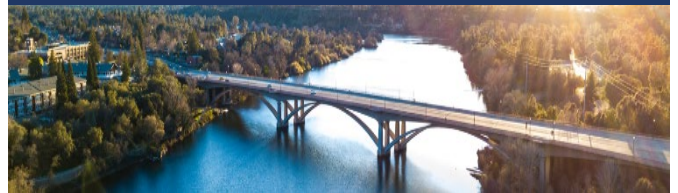
Output Delivered

- Held 110 County Touchpoints, with 162 support areas identified; resulting in 148 areas addressed by the C.O.E. covering 91% of County needs
- 18 interventions planned and executed to address common support needs across multiple Counties:
 - 1 Super User Community deployed (300+ users) to all 39 C-IV Counties; enabled via the Forumbree platform
 - 4 hotspot learning aids
 - 2 ServiceNow Knowledge Articles
 - 6 county workshops/office hours
 - 5 program recommendations/infographics
- Advanced readiness and awareness of upcoming system enhancements and business impacts

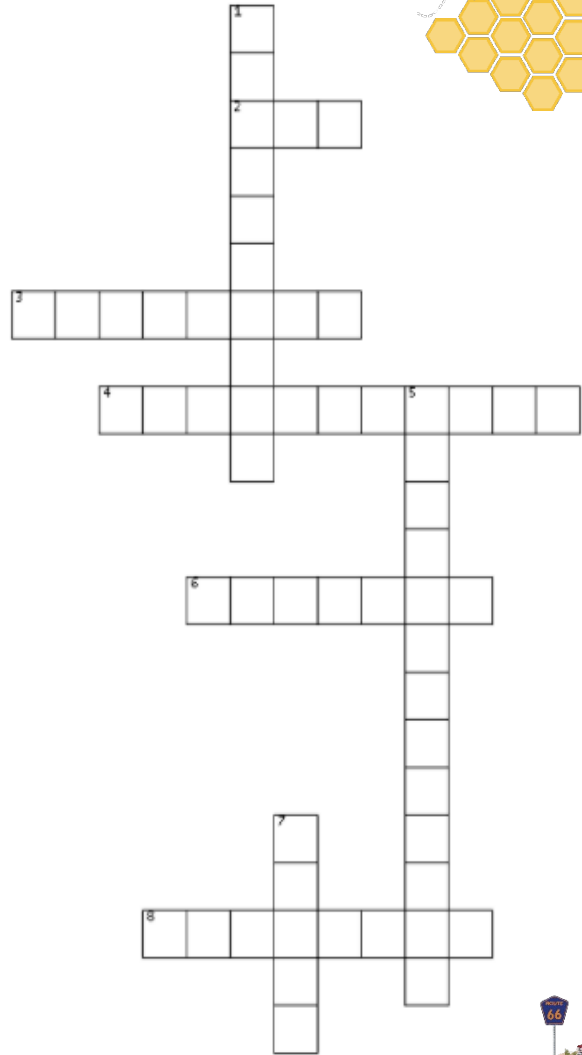
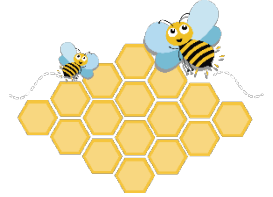
