Description:	<p>Purpose The purpose of this CIT is to provide CalSAWS counties with instructions on processing Non-MAGI cases with an income selection of "Child/Spousal Support Child Support - Through LCSA."</p> <p>Background Effective 01/2022, SCR CA-217945 added a change to the system that was to update the child support disregard from \$50 to \$100 for the CalWORKs (CW) program. However, the change was also applied to the Medi-Cal (MC) Non-MAGI program for the income selection of "Child/Spousal Support Child Support - Through LCSA." In release 22.05, defect CA-241131 will restore the child support disregard back to \$50 for the MC program.</p> <p>Additional Information: There is currently no impact to MAGI Medi-Cal cases as Child Support income is exempt for MAGI.</p> <p>County Action: Until CA-241131 is released, if the Non-MAGI eligibility determination incorrectly applies the \$100 child support disregard and there is an impact to the benefit results, counties must complete an EDBC override to issue the correct benefits.</p>
