Description:	<p><b>Purpose</b> The purpose of this CIT is to provide CalSAWS counties the batch memorandum associated with <b>CA-212913 ACL 19-76 - CalWORKs Change in Earned Income Disregard (EID) 2022</b> and <b>CA-232078 ACL 19-76: Batch EDBC Run to Apply 2022 Earned Income Disregard</b>.</p> <p><b>Background</b> <a href="#">ACL 19-76</a> - CalWORKs Income Exemptions and Income Reporting Thresholds outlines the SB 80 increases to the Earned Income Disregard (EID) for CalWORKs recipients.</p> <p>The following SCRs will be implemented in Release 22.03 to update the CalWORKs EID (Cash Aid, Immediate Need, Refugee Cash Assistance, and Kin-Gap):</p> <ul style="list-style-type: none"> <li><b>CA-212913</b> will increase the CW Disability Based Earned and Unearned Income Disregard from \$550 to \$600, effective June 1, 2022.</li> <li><b>CA-232078</b> will run Batch EDBC on May 14, 2022, for the June 2022 benefit month. This will apply the new EID value for active CalWORKs, RCA and Kin-Gap programs.</li> </ul> <p><b>Additional Information:</b> A separate CIT for lists associated to the 2022 EID increase will be sent after the batch job is completed and the lists are available.</p>
